

CARAVAN PARK CAMPING

Accommodation Rules and Regulations

Art. I - Introductory provisions

1. These Accommodation Rules and Regulations are valid throughout the entire CARAVAN PARK CAMPING premises (hereinafter also referred to as the “premises”) and are binding on all persons staying on the premises.
2. By entering the premises, each person undertakes to become acquainted with these Accommodation Rules and Regulations and to comply with them.
3. Any person who violates these Accommodation Rules and Regulations may be expelled from the premises by the operator without compensation. In the event of damage or destruction of the facility of the accommodation provider, the person responsible for the damage will be charged an amount corresponding to the caused damage to the operator, the minimum amount being 2000CZK.

Art. II - Registration and Accommodation

1. Only persons who present their valid identity card (identity card, passport, etc.) and truthfully fill in the guest card can be accommodated on the premises. The provision of such personal data is based on:
 - i. Act No. 326/1999 Coll., the Residence of Foreigners in the Czech Republic
 - ii. Act No. 565/1990 Coll., the Czech National Council Act - Local Fees
 - iii. Act No. 89/2012 Coll., the Civil Code

All provided data are used only for the guests' registration, arising from the above-mentioned laws, and these data are provided only to institutions designated by law. Additionally, the data will be processed according to Act No. 110/2019 Coll., the Processing of Personal Data, and according to Regulation (EU) 2016/679 of the European Parliament and the Council from 27 April 2016 about the protection of individuals' personal data and the free movement of such data and about repealing of Directive 95/46 / EC (General Data Protection Regulation).

2. Reception and accommodation of guests is possible only up to the capacity of the premises.
3. Each new guest is obliged to pay fees for the entire stay before entering the premises according to the currently valid price list.
4. After registration, filling in the guest card and paying the price for the whole stay, each resident receives:
 - a proof of payment;
 - a permit to enter the premises, which has to be displayed on a visible part of the car, caravan or tent;
 - returnable shower tokens.
5. The guest may be given a designated parking space by an employee of CARAVAN PARK.
6. A group of guests can only be accommodated upon a written reservation confirmed prior to the stay.
7. Check-in or extension of stay is possible from 9:00 to 18:00.
8. The guests are obliged to check out and leave the premises no later than 12:00 on the last paid day.
9. Guests can extend their stay at any time from 9:00 to 18:00, but no later than 12:00 on the last paid day.
10. In case of an early termination of the stay by the guest, the payment for the rest of the stay is not refundable.
11. A guest who is found not to have paid for their stay on the premises shall be immediately expelled from the premises with the obligation to pay a contractual penalty equal to twice the amount due, but at least 1000CZK.
12. The guests are obliged to inform the reception staff about any pets entering the premises. A fee specified in the price list will be paid for the stay of the animal. At the request of the camp employee, the guest is obliged to present the vaccination certificate of the animal indicating valid vaccination.

Art. III - use of the premises

1. There are electrical connections (14A) on the premises, which the guest is authorized to use only with a valid revision test for the given facility (caravan) or for approved and certified appliances.
 - These connections are used to connect and recharge caravans equipped with small electric appliances (radio, television, fridge).
 - It is forbidden to connect electric cookers of any kind, electric heaters, washing machines, dryers, etc.
 - It is strictly forbidden to handle the switchboards.
 - Potential damages are paid by the connected user.
 - Users of electrical connections must not provide electricity to anyone else.
2. All guests are obliged to ensure order and cleanliness throughout the premises, within their place (around the tent, caravan, motor vehicle, etc.), and especially in sanitary facilities.
3. Guests are obliged to dispose of municipal waste using only the designated containers at designated areas outside the premises. It is not allowed to store or burn any waste on the premises, including the waste pits.
4. Waste water and chemical toilets may only be discharged at designated locations.
5. Making a fire is prohibited except for the use of outdoor grills.
6. For safety reasons, it is not allowed to leave children unaccompanied by adults on the campsite. Parents or children's guardians are responsible for the safety of their children moving around the campsite!
7. Dogs and other animals are only allowed to enter the campsite on a leash.
 - The owner of an animal is responsible for the immediate cleaning up of excrements and other clutter caused by their pet throughout the premises.
 - It is strictly forbidden to walk animals throughout the CARAVAN PARK.
 - Swimming/bathing of animals is not allowed throughout the CARAVAN PARK!
8. The time period from 10 pm to 7 am is officially a quiet period and all guests must respect it.

9. It is also necessary to be respectful to other guests in the area during the day, not disturbing them by excessive shouting, singing, listening to loud music, unjustified driving, etc.
10. Any motor and other vehicles, e.g. bicycles, may only be operated on designated roads and paths. The speed limit in the entire campsite area is 5 km/h. Visitors can only drive at a speed that does not disturb other guests by whirled dust and does not put other guests or their belongings in danger. Unjustified driving and use of light and sound signals are not permitted. Additionally, it is forbidden to keep the engine running.
11. Washing and maintenance of motor vehicles is prohibited throughout the area.

Art. IV - Disclaimer

1. The operator of the premises is not liable for the things brought into the campsite area by the guests.
2. The operator of the premises is not responsible for any car damage or theft.
